The consent is the responsibility of the entrant and by agreeing to these terms and conditions the entrant agrees that they have obtained this consent. Westernport Water™ and savewater!® will not be held responsible/accountable for promoting/displaying personal images of people/persons who have not agreed to their images being used in the public domain.
6. Photographs must be submitted in JPEG or TIF format
7. Entry forms must be completed in English
8. Photographs must be uploaded onto [www.savewater.com.au](http://www.savewater.com.au) No hardcopy photographs will be accepted. Retain a copy of your entry for your own purposes.
9. Entrants are allowed to submit a maximum of 3 photographs, with each photograph only permitted to be entered once and only in one sub-category.
10. The entrant acknowledges that the use of the photograph will result in readers and viewers being able to identify the entrant.
11. Entries close at 5pm (AEST) on Friday 20<sup>th</sup> July 2012. Strictly no extensions will be granted.
